#### 5.5 To approve the utilization of the sanctioned budget of Rs. 15 lakhs.

Prof. Dr. Ms. Vandana K. Purohit, Member Secretary of the Finance Committee reported the following during the Governing Body Meeting:

- 1) Dr. Ms. Purohit stated that the UGC budget of Rs. 15 lakhs were utilized tentatively for the expenditure incurred in the financial year 2021-22 in accordance with the applicable UGC norms.
- 2) Submission of a Utilization Certificate and a Statement of Expenditure to the UGC, WRO, Pune for the financial year 2020-21.

The Member Secretary of the Finance Committee also informed the members of the Governing Body Committee that on March 9<sup>th</sup> 2022, the Utilization Certificate and Statement of Expenditure for the financial year 2020-21, duly signed by the Chartered Accountant and the Principal of the College, were submitted to the UGC, WRO, Pune. She further informed that the follow-up of the UGC grants for Autonomous Colleges for the year 2020-21 was done through official letters and telephone. She added that the funds were used by the Finance Committee to meet the additional and specific needs such as syllabus upgrades, redesigning courses, and developing teaching / learning materials, as well as honoraria for BOS, AC, and GB members, exam reforms, furniture, classroom renovations and repairs (elearning), laboratory equipment, honoraria for guest / visiting faculty, books and learning materials, and so forth.

The esteemed Members of the Governing Body made the following recommendations following the presentation by the Member Secretary of the Finance Committee:

- Dr. C. B.Nadgouda proposed that a column showing the percentage of grant funds spent on each item should be included. This will aid in a better understanding of grant allocation and expenditure.
- Dr. C. B. Nadgouda also mentioned that the budget for Webinars and Seminars was underutilized. Dr. Ms. Purohit explained that due to the COVID 19 pandemic, the meetings and webinars were conducted online throughout the year, resulting in decreased expenditures.
- In response to a question from Dr. S. M. Todkari regarding carrying forward of the unutilized grants to the next financial year, Dr. C. B. Nadgouda suggested revising and resubmitting the budget expenditures to the UGC in January each year. Principal Dr. S. V. Koti, justified this suggestion by mentioning that a 5% re-appropriation of budget expenditure can be reimbursed from UGC.

The report on utilization of the sanctioned budget of Rs 15 lakhs was approved unanimously by the Governing Body members.

#### 5.7 Any other item with permission of the Chairman.

The first AQAR after acquiring autonomy and the report of External IQAC Peer team for the year 2020-21 was presented in the meeting by the IQAC Coordinator Dr. R. V. Desai.

The suggestions given by External IQAC Peer team were appreciated by Hon'ble Dharmraj Kadadi and Principal Dr. S. V. Koti.

General points were discussed by the committee members and following suggestions were given by the committee members:

- Dr. S. V. Koti suggested that free Wi-fi access should be made available in monitored areas like reading room in the library, departments, etc. He also added that it should not be made available in the entire campus to prevent its misuse. Dr. S. V. Koti recommended that the Action Taken Reports should be collected from various BOS Chairmen. He also suggested that Expert Talks on Research should not be arranged frequently but once in a term if feasible as suggested by the External IQAC Peer team.
- Dr. C. B. Nadgouda enquired about Student's Feedback on teachers and the corrective action taken. The IQAC coordinator Dr. Desai reported that the feedback on teachers was collected online and reported to the Principal who discussed the issues with the teachers concerned and instructed them. He also informed the committee members that in 2021-22 the student feedback will be collected from the Student Diary App.
- Hon'ble Secretary Dharmraj Kadadi enquired about the Best Practices followed by the institute, the way they are formed and implemented. Dr. R. V. Desai explained the method followed by the IQAC. He said that he has formed groups of faculties headed by each criterion- in-charge. They conduct discussions on the experiences, requirements, problems encountered, etc. of the previous academic year, based on the information on the NAAC website. Finally, they suggest at least 2 to 3 best practices. Dr. S. V. Koti suggested linking the best practices to the student feedback. Dr. R. V. Desai also reported that various policies for the same are being formed by Mr. D. M. Metri, Convener, of Best Practices.
- Dr. S. V. Koti suggested that it should be made mandatory for the teachers to publish their research papers in UGC Care listed Journals only.
